Information about authors

Fiona Allison is the Senior Research Officer with the Indigenous Legal Needs Project and is based at The Cairns Institute, James Cook University.

Terry Burke is a Professor at the Institute for Social Research, Swinburne University of Technology. His research interests are lower income housing (public and private rental housing), housing affordability, urban segregation, and comparative urban and social policy.

Chris Cunneen is Professor of Criminology at The Cairns Institute, James Cook University, and a chief investigator with the Indigenous Legal Needs Project.

Eric Emerson is Professor of Disability Population Health at the Centre for Disability Research and Policy, University of Sydney. He is also Professor of Disability & Health Research at the Centre for Disability Research, Lancaster University and Co-Director of the English specialist Public Health Observatory on intellectual disabilities. His main research interests lie in understanding and addressing the health and social inequalities faced by people with disabilities and he has authored over 280 publications related to these issues.

Alan Fenna is Professor of Politics at the John Curtin Institute of Public Policy, Curtin University. He publishes chiefly in the areas of economic and social policy, federalism and constitutional issues.

Lucy Groenhart is an Australian Housing and Urban Research Institute Postdoctoral Fellow at the Institute for Social Research, Swinburne University of Technology. Her research interests are housing policy, with a focus on social housing and tenure mix; and urban policy evaluation.

Anne Honey is a Senior Lecturer with the discipline of Occupational Therapy, Faculty of Health Sciences, University of Sydney. Her research focuses on young people with long-term conditions within families and communities. Anne has published in the fields of disability, adolescent eating disorders, mental health, and vulnerable families.

Maina Kariuki was a Research Associate with the Australian Family and Disability Studies Research Collaboration at the University of Sydney when this work was undertaken, and is currently a postgraduate student in health biostatistics at the University of Sydney.

Jacqueline Laughland-Booy is a PhD candidate in the School of Social Sciences at Monash University. Her PhD thesis explores the attitudes of young Australians towards asylum seekers.

Gwynnyth Llewellyn is Professor of Family and Disability Studies and Director of the Centre for Disability Research and Policy at the Faculty of Health Sciences, University of Sydney. This Centre aims to contribute actively to the challenge presented by the World Report on Disability (World Health Organization and the World Bank, 2011) of strengthening and supporting research on disability for evidence-informed policy and practice development. Professor Llewellyn's research areas are in family and disability studies, disability and development, and disability and disadvantage.

Erin O'Brien is a Lecturer in the School of Justice, Queensland University of Technology. She researches agenda-setting, policy-making and political activism, and is particularly concerned with the interplay between activists and the state in the construction of knowledge and formation of policy. Her current research examines political discourse on human trafficking, asylum seeking, and migration.

John Phillimore is Professor and the Executive Director of the John Curtin Institute of Public Policy at Curtin University. He has worked in the Western Australian government as chief of staff and adviser to ministers, and as head of intergovernmental relations advising the Premier. His current research interests include federalism, higher education, innovation policy, and social policy.

Elizabeth Rowe is a PhD Candidate in the School of Justice, Queensland University of Technology. Her research interests include the political and social construction of marginalised groups in society, with a focus on refugee, asylum seeker and immigration policy and issues. Her PhD research examines asylum seeker and refugee experiences of the migration journey and resettlement in Australia.
